QUORUM FOR MEETINGS:

- 1. The quorum for the meeting of the Executive shall be 1/3 of the members.
- 2. In the absence of the President and the Secretary, the members will elect any member from among those present to preside over the meeting.

DISQUALIFICATION:

Any member of the PTA committee, who absents for three consecutive meetings without any reasonable cause, shall cease to be a member. Information to this effect shall be conveyed to the member concerned.

FILLING IN OF VACANCIES:

Any vacancy in the PTA committee of office bearers may be filled in by the Executive Committee bout the term of such members will end with other members.

MEETING OF THE PTA:

<u>Meeting:</u>Meeting of the Executive Committee will be held on 2nd Saturday of every month.

DECISION IN MEETING:

Decision in the meeting of the PTA Committee shall be by majority of vote. In case of a tie the President shall have casting vote.
